Thank you for submitting an Application for Approval of Marine Event for the **Ida Lewis Yacht Club's Aloha Spring-Summer-Fall Series, to be held in the East Passage of Narragansett Bay between Castle Hill and the Newport Bridge on June 3, 2017, July 1, 2017 and August 26, 2017 from 11 a.m. to 5:00 p.m.** I have reviewed your application and determined that your event does not require a Coast Guard permit because it does not meet all of the following criteria:

1. An organized event
2. Of limited duration
3. With a prearranged schedule
4. Likely to interfere with navigation
5. Likely to introduce any extra or unusual hazards
6. Navigation cannot be addressed through the Rules of the Road

If there are any substantive changes to your event, please contact the Coast Guard. Substantive changes may include the number of participants and/or expected spectators, location, or any other significant changes that may necessitate reconsideration as to whether a permit is required.

Although a Coast Guard permit is not required, you are still responsible for the overall safety of the event, for obtaining appropriate permits from other Federal, State, or local authorities, and for complying with all existing Federal, State, and local laws and other requirements that may impact your ability to hold your event as proposed.

I sincerely appreciate your proactive effort in bringing your event to my attention. Because of the dynamic nature of the waterway, boating, and maritime activities, the Coast Guard carefully considers the totality of the risks associated with each event on a case-by-case basis when determining whether a permit is required. While a Coast Guard permit is not required for this occasion, you must continue to submit an Application for Approval of Marine Event for this and any similar events you may sponsor in the future.
